Executive Summary

his report describes the important and unique role of National Association of Public Hospitals and Health Systems' (NAPH) member hospitals in our nation's health care system. NAPH has conducted an annual member survey since the mid-1980s. This report includes information about 82 of our members' financial performance and utilization volumes from our most recently completed survey, for the fiscal year 2002. (See Appendix A for a description of the survey methodology.) The report also contains information about our members and the markets that they serve derived from the American Hospital Association (AHA) annual survey of hospitals for the same year.

Overview of Key Findings

Key findings about NAPH member public hospitals and health systems in fiscal year 2002 include the following:

- NAPH hospitals and health systems had a slightly negative margin of -0.3
 percent in 2002. The margins of NAPH members continue to lag significantly
 behind those of other hospitals in the industry. In 2002, the average margin of
 all hospitals nationwide was 4.5 percent.
- More NAPH members experienced negative margins in 2002 compared to 2001. Fifty-two percent of NAPH member public hospitals lost money in 2002 compared to 42 percent in 2001.
- In fiscal year 2002, NAPH member hospitals and health systems provided \$5.4 billion in uncompensated hospital care costs, representing over 24 percent of the uncompensated hospital care in the U.S.
- Uncompensated care represents 21 percent of NAPH members' costs as compared to 5.4 percent of costs for hospitals nationally.
- NAPH members continue to rely heavily on government funding sources.
 Seventy-one percent of NAPH member hospitals and health systems' net revenues come from Medicaid, Medicare, and state and local governments.
 Reimbursement from these sources is not adequate to cover the costs of providing patient care.
- In fiscal year 2002, 90 percent of NAPH members lost money on Medicare.
 Even with Medicare disproportionate share hospital (DSH) and indirect medical education (IME) payments included, NAPH member public hospitals lost \$903 million treating Medicare patients.
- Medicaid continues to be a significant source of revenue for public hospitals and health systems. In 2002, Medicaid provided 37 percent of total net revenues for NAPH members.
- Medicaid DSH payments cover nearly one-quarter of unreimbursed costs for NAPH member systems partially compensating for losses on Medicaid, Medicare, and uninsured patients.
- Despite its importance, in many states Medicaid falls short of adequately covering the costs of providing low-income care for many NAPH hospitals and

- health systems. Even with Medicaid DSH payments included, 56 percent of members lost money on care provided to Medicaid patients.
- NAPH members provide an extraordinary volume of ambulatory care. In 2002, the average NAPH member provided triple the volume of emergency department visits and non-emergency ambulatory care visits provided by the average acute care hospital nationally and double that provided by the average acute care hospital in the predominantly urban markets (or counties) in which they are located. Forty-six percent of ambulatory care visits provided by NAPH members were for primary care.
- NAPH member public hospitals and health systems play a vital role in emergency and disaster preparedness. In 23 communities in the U.S., NAPH members are the only Level 1 trauma center or the only trauma center of any level. In 16 communities, they are the only providers of burn care. NAPH members in Chattanooga, Las Vegas, Memphis, and Miami are the only providers of both trauma and burn care in those communities.

Conclusion & Recommendations

Public hospitals and health systems bring high quality health care to all people in their communities, even those who cannot afford it. These providers meet many health and other needs in their communities — including trauma and burn care, neonatal intensive care, mental health services, and preventive and specialty care. However, data from the 2002 NAPH member survey shows that public hospitals meet the growing health care needs of their communities with increasingly inadequate resources. In 2002, the average NAPH member lost money. More than half of NAPH members had negative margins. Many health systems that operated in the black had only small positive margins.

NAPH members are a crucial component of the nation's safety net infrastructure. They provide high quality medical care and ensure health care access to all, including the nation's growing number of uninsured and underinsured individuals and families. NAPH hospitals and health systems also operate many of the nation's trauma and burn centers as well as some of the country's busiest emergency rooms. These providers also work closely with local public health departments and other first responders like police, fire, and emergency services to coordinate response in the event of terrorist attacks.

Given the important role public hospitals play in caring for the communities that they serve, federal, state, and local policy-makers must make a continued and sustained investment in strengthening our nation's public hospitals and health systems.

The Situation of NAPH Member Hospitals, 2002

embers of the National Association of Public Hospitals and Health Systems (NAPH) share the mission of treating all patients regardless of their ability to pay. As safety net hospitals, they provide a significant volume of care to millions of low-income, uninsured, and vulnerable individuals and families and are an essential part of the nation's health care infrastructure. They provide care to "at risk" populations such as the elderly, low-income families on Medicaid, minorities, and individuals with chronic illnesses such as HIV/AIDS, mental illness, diabetes, and asthma. Additionally, NAPH members are leading providers of essential, high cost, around-the-clock services that everyone in their community, regardless of income or insurance status, relies upon, including trauma care, burn care, neonatal and pediatric intensive care, and emergency care.

This report describes the situation of NAPH members in 2002, the latest year for which data are available.


Trends Affecting the Safety Net

Financial Performance

NAPH members struggled financially in 2002, and their operating margins continued to lag behind those of other hospitals in the industry. In 2002, NAPH hospitals and health systems had an average margin of -0.3 percent as compared to an average margin of 4.5 percent for all hospitals nationwide (See Figure 1). Fifty-two percent of NAPH members lost money in 2002, compared to 42 percent in 2001. Almost two-thirds of NAPH members had margins of less than 2 percent. According to industry analysts, margins of less than two percent are inadequate for financing working capital or reinvesting in infrastructure and technology, not to mention financing the special services that make public hospitals the core of our nation's safety net.

While NAPH members have historically had to struggle to ensure their viability while fulfilling their safety net missions, these hospital systems are facing increased burdens. In the last decade, the number of uninsured and underinsured has risen in the U.S. as a result of a poor economy. Recent federal and state budget deficits have led to crippling funding cuts in Medicaid and other health care programs. Public hospitals and health systems have led the way in preparing our nation to respond to bioterrorism and other public health threats. Many public hospitals have had to address capital needs that they could no longer postpone.

All have had to respond to new privacy and patient safety regulations that require significant investments in systems and other equipment. Continuing medical workforce shortages have driven up labor costs. And double-digit increases in pharmaceutical prices have caused costs associated with patient care to rise faster than revenues. Barely breaking even is insufficient to guarantee survival in such an inhospitable environment.

Changes in Government Support of Safety Net Hospitals

NAPH members uniquely rely on government funding sources, as 71 percent of their net revenues come from Medicaid, Medicare, and state and local governments. At the federal, state, and local levels, public hospitals have faced budget cuts in the last several years in spite of new challenges and demands for services.

Medicaid has historically been a significant source of revenue for public hospitals and health systems. In 2002, Medicaid represented 37 percent of total net revenues for NAPH members. Yet without Medicaid DSH payments, which are intended to reduce shortfalls providers experience in treating Medicaid patients and to partially subsidize care to the uninsured, the Medicaid payment-to-cost ratio for NAPH members was only 0.77. Without Medicaid DSH, NAPH members would have lost over \$1.8 billion on the care of Medicaid patients. But even with DSH, 57 percent of members still lost money on care provided to Medicaid patients.

In 2002, NAPH members once again experienced significant losses on the care of Medicare patients. Ninety percent of NAPH members lost money on Medicare patients in 2002, for a total of \$903 million. When taking subsidies from Medicare DSH and indirect medical education (IME) funding into account, the Medicare payment-to-cost ratio remained at 0.81 in 2002. Without DSH and IME funds however, the average Medicare payment-to-cost ratio for NAPH members would have been a mere 0.65 in 2002.

State and local government subsidies have remained relatively steady since the mid 1990s, hovering between 14 percent and 16 percent of costs for a matched set of NAPH members. In 2002, the revenues received by this same matched set of hospitals and health systems from their state and local governments covered 15 percent of their total costs.

Commitment to the Uninsured

The latest uninsured figures from the Kaiser Commission on Medicaid and the Uninsured indicate that there were 43 million Americans without health insurance in 2002. That number represents a 10 percent increase over the number of uninsured just two years earlier, an increase largely attributed to the downturn in the economy. In addition, another 30 million people are estimated to be underinsured. This group consists primarily of persons with high deductible, catastrophic insurance policies, and out-of-pocket costs that they often cannot afford to pay. Care for these uninsured and underinsured populations is often provided by public hospitals whose mission is to serve all patients regardless of ability to pay.

As leading providers of low-income care, NAPH members have had historically high rates of uncompensated care as a percent of total costs. Twenty-one percent of NAPH members' costs are uncompensated, as compared to 5.4 percent of costs for hospitals nationally. In 2002, just 81 NAPH members provided almost a quarter of the uncompensated hospital care in the country.

Shift to Ambulatory Care

Over the past decade, NAPH members have experienced remarkable growth in the amount of ambulatory care that they provide. This ambulatory care growth has been accompanied by steady decreases in discharge volumes. The combination of these trends is troublesome for NAPH members because much of the ambulatory care these health systems provide is to uninsured patients, which means that much of their care is unreimbursed. In 2002, 38 percent of ambulatory care services were provided to uninsured patients as compared to 23 percent of inpatient services (See Tables 3 and 4 in Appendix B).

Improved Medicaid Enrollment


NAPH survey data indicate that during the late 1990s, Medicaid discharges dropped 16 percent for a matched set of members (from an average of 8,730 discharges in 1996 to 7,365 discharges in 1999) (See Figure 2). This decrease was due to competition from other providers that had not traditionally served the Medicaid population. Medicaid payment rates from managed care made Medicaid patients more attractive to these providers who began marketing their services to attract pregnant women covered by Medicaid. NAPH members lost a significant fraction of their Medicaid birth market share, resulting in a reduction in overall Medicaid discharges.

Since 1999, NAPH members have been taking measures to reverse this trend. Discharge volumes began to increase as health systems more actively used Medicaid enrollment campaigns and began more aggressive financial screening of uninsured patients. These efforts have led to increased success in obtaining coverage for uninsured individuals. Between 1999 and 2002, the volume of Medicaid discharges at NAPH facilities increased by 8 percent.



In addition to their screening and enrollment efforts, members have worked aggressively to retain their Medicaid market share of births. Updating their birthing facilities with state-of-the-art labor, delivery, and recovery suites and increasing the number of private post-partum rooms are measures that are paying off for NAPH members, who have experienced an increase in births since 1999 (See Figure 3). In 2002, NAPH members delivered over 18 percent of all births in their markets.

Characteristics of NAPH Members


Role in Providing Low-Income Care

A majority of the care that NAPH members provide is to patients who are uninsured, underinsured, or covered by the Medicaid program. In 2002, an average of 37 percent of patients discharged from NAPH hospitals were covered by Medicaid and another 23 percent of patients were uninsured (See Figure 4). Patients covered by Medicare or commercial insurance represented 21 percent and 19 percent of the discharges, respectively (See Table 3 in Appendix B for data on individual NAPH members).


NAPH members provide an even higher proportion of care to low-income populations through their ambulatory care networks. Much of this care is unreimbursed. Over two-thirds of the outpatient visits that NAPH members provided was to uninsured and Medicaid patients (38 percent and 27 percent, respectively). Fifteen percent of outpatient visits were for Medicare patients, and the remaining 20 percent were provided to commercially insured patients (See Table 4 in Appendix B for data on individual NAPH members).

Systems by Payer Source, 2002



In 2002, 81 NAPH members provided almost \$44 billion in total inpatient and outpatient services, averaging more than \$542 million per member hospital or health system. Thirty-two percent of these services was provided to Medicaid patients and 25 percent was provided to self-pay patients (See Figure 5). Medicare and commercially insured patients accounted for 21 percent and 22 percent of services, respectively. (See Table 6 in Appendix B for data on individual NAPH members.)



NAPH hospitals and health systems collected nearly \$23 billion in revenues, an average of more than \$284 million per member. These providers continue to rely primarily on a combination of federal, state, and local funding sources to sustain their operations. In 2002, 71 percent of revenues for NAPH members came from federal, state, and local payments, including 37 percent from Medicaid, 19 percent from Medicare, and 15 percent from state and local subsidies (See Figure 6). An additional 22 percent of revenues came from commercially insured patients, while uninsured patients accounted for only 7 percent of net revenues (See Table 7 in Appendix B for data on individual NAPH members).



Financing Unreimbursed Care

The term "unreimbursed care" describes losses on care provided to Medicare, Medicaid, and self- pay patients, excluding "mission-related" funding such as DSH payments, indirect medical education payments (IME), and state and local government subsidies. In 2002, 77 NAPH members lost over \$1.7 billion on care provided to Medicare patients (without Medicare DSH and IME payments) and over \$1.8 billion on care provided to Medicaid patients (without Medicaid DSH payments).

As Figure 7 indicates, state and local subsidies financed 39 percent of the unreimbursed care provided by NAPH members in 2002. Medicaid DSH was a critical funding source, financing almost a quarter of the unreimbursed care provided. Medicare DSH and IME subsidized 10 percent of unreimbursed costs,

Net Revenues by Payer Source at NAPH Hospitals and Health Systems, 2002



with Medicare DSH covering six percent of costs and IME payments covering four percent. Revenues unrelated to patient care, which can include interest and investment income, cafeteria and parking revenues, medical record fees, sales tax, tobacco settlement monies, and rental income, covered the remaining 28 percent of unreimbursed costs.

Role of Safety Net Facilities

NAPH member public hospitals and health systems represent only 2 percent of acute care hospitals in the nation and 12 percent of acute care hospitals in their respective markets, yet these health systems are often the major providers of inpatient care, outpatient care, and specialized services within the communities that they serve (See Figure 8). In 2002, the average NAPH member provided triple the volume of emergency department visits and non-emergency ambulatory care visits provided by the average acute care hospital nationally and double that provided by the average acute care hospital in the predominantly urban markets (or counties) in which they are located. On the inpatient side, the volume of hospital admissions provided by the average NAPH member was more than double that provided by the average acute care hospital nationally. Admissions at NAPH hospitals also exceeded those at the average hospital in their markets by 30 percent.










NAPH member hospitals and health systems tend to be larger than other acute care hospitals nationally and in their markets. NAPH facilities have, on average, 381 beds, making these hospitals 1.3 times larger than the average acute care hospital in their markets and more than double the size of the average acute care hospital nationally. However, there is a great deal of variation in bed size across the NAPH membership. As Figure 9 shows, while 36 percent of NAPH members have fewer than 250 beds, 30 percent have between 251 and 450 beds, 32 percent have between 451 and 1000 beds, and 2 percent have more than 1000 beds.


Inpatient and Outpatient Care Volumes

According to American Hospital Association survey data for fiscal year 2002, the average inpatient volume for NAPH acute care facilities was 2.2 times greater than for the average acute care hospital nationally (17,068 admissions versus 7,277 admissions for the average acute care hospital nationally). Despite the volume of care provided however, data collected for a matched set of members through the NAPH Hospital Characteristics Survey over the past nine years indicates a significant decline in discharges since 1993. While the average discharge volume since 1996 has remained relatively stable, current volumes remain about 10 percent lower than they were in the early 1990s (See Figure 10). Much of this decrease was due to the loss of Medicaid patients, particularly obstetrics patients, as described in the Medicaid enrollment section.

Over the past decade, NAPH members have seen a steady increase in the volume of outpatient care that they provide. AHA data indicate that between 1993 and 2002, a matched set of 81 NAPH hospitals and health systems experienced an increase of over 26 percent in the average volume of ambulatory care visits provided, from just under 276,000 visits in 1993 to over 368,000 visits in 2002 (See Figure 11).²

Public hospitals and health systems not only provide ambulatory care through their on-campus hospital clinics, but also through extensive community clinic networks that include free-standing clinics, mobile units, and clinics in schools and housing developments. By developing such an extensive community presence, these health systems have become leading providers of outpatient primary care services. NAPH survey data indicate that of the 28 million non-emergency ambulatory care visits provided by NAPH members in 2002, 46 percent of these were for primary care.



Emergency Preparedness Activities

NAPH member public hospitals and health systems are among the nation's leading providers of emergency room, trauma, and burn care services and have long been first responders for such tragedies as chemical spills, fires, disease outbreaks, and natural disasters. Safety net hospitals and health systems now play a key role in ensuring homeland security. Their work in the area of emergency preparedness includes working with local governments, health departments, and other first responders like police, fire and emergency services to coordinate communication and response in the event of a terrorist attack. The strong relationships that many NAPH members have with their local public health departments allow them to monitor disease trends to identify any potential incidents of bioterrorism or outbreaks of disease.

Trauma care is another highly specialized service provided by safety net hospitals and health systems. Trauma centers are facilities that are specially equipped to provide emergency and specialized intensive care to critically ill and injured patients. Level I trauma centers, the most highly specialized centers, are equipped to provide total care for every aspect of injury. They also play a leading role in trauma research and education. In 23 communities, including several major cities such as Albuquerque, Atlanta, Las Vegas, Memphis, Miami, New Orleans, Richmond, and San Francisco, NAPH members are either the only Level I trauma center or the only trauma center of any level (See Figure 12).

² AHA data on outpatient visits are used so that NAPH member data can be compared to that of hospitals in their markets and in the rest of the nation. This AHA data, referenced in Figure 11, differ slightly from that reported in Appendix B-Tables 2 and 4 because the AHA survey database includes a higher number of NAPH members.

Burn care is another essential and highly specialized service provided by safety net health systems. In 16 communities across the country, including cities such as Cleveland, Dallas, Denver, Las Vegas, Memphis, Miami, and Minneapolis, NAPH member hospitals are the only providers of burn care (See Figure 13). In many cases, the NAPH members in these communities are the only burn care providers not only for their designated markets, but also for communities in neighboring counties or even states.

Role in Training the Nation's Physicians and Other Health Professionals

NAPH hospitals and health systems play a pivotal role in training the country's physicians, nurses, and other health care professionals. Eighty percent of NAPH member public hospitals are teaching institutions. Fifty-one percent are additionally classified as academic medical centers, defined as having four or more approved residency programs.

In 2002, NAPH members trained almost 11,500 full-time equivalent (FTE) medical and dental residents and over 500 FTE allied health professionals. This accounts for 15 percent of the doctors and more than 19 percent of the allied health

professionals who received their training at acute care facilities during that year. In the markets in which they are located, NAPH members play an even larger role in teaching health professionals. In 2002, NAPH members trained 31 percent of the medical and dental residents and 35 percent of the allied health trainees in their markets (See Figure 14).



Community Health Services

Most NAPH member public hospitals have close ties to their county health departments, and a significant number are responsible for public health services in their communities. In several major cities across the country, including Cambridge, Chicago, Denver, Los Angeles, Martinez (CA), and San Francisco, the CEO of the safety net hospital or health system is responsible for running the local public health department.

NAPH hospitals and health systems play a leading role in various efforts to improve the health status of the communities they serve. NAPH members have established programs to provide immunizations, address problems with teen pregnancy and low birth-weight, prevent violence and injury, and provide mammography and other cancer screenings. In the markets that they serve, NAPH acute care hospitals comprise 23 percent of hospitals providing community outreach services, 29 percent of those providing teen outreach services, and 35 percent of those providing crisis prevention services. They also comprise 31 percent of hospitals providing reproductive health services and 38 percent of those providing dental services.

Common Governance Structures


he NAPH membership can be categorized into three governance models: direct operation by local or state governments (or state university), separate public entities, and non-profit corporations. (See Appendix C for a list of NAPH members by governance structure.) Within these general categories, there might be some variations designed to address health systems' specific needs.

Of the NAPH member hospitals who participated in the 2002 Survey, 40 percent reported that they are operated directly by their local or state government or state university (See Figure 15). This governance structure offers little flexibility, and often imposes civil service requirements, procurement rules, and sunshine laws. These requirements provide health systems little autonomy, affecting their ability to plan strategically and to react proactively in competitive situations. Some NAPH members have subsequently chosen to move towards other governance arrangements that allow for more flexibility.

Half of all NAPH members are organized as separate public entities. Within this governance structure, health systems may be organized as a separate board within a governmental entity, a hospital taxing district, a hospital authority, or a public benefit corporation (See Figure 16 for descriptions of these models).

The remaining 9 percent of NAPH members are non-profit corporations. Under this model, health systems tend to be structured as tax-exempt corporations under a contractual agreement with the local government to provide health services to the uninsured and underserved. In some cases, the local government may retain some control over board appointments or other aspects of the corporation.

Separate Board within Governmental Entity:

The hospital or public health board has authority to manage the daily operations of the hospital. This entails a higher degree of autonomy than direct operation by state or local government.

Hospital Taxing District:

An independent instrumentality of the state government with taxing authority and defined geographic boundaries. A district is typically organized under state legislation.

Hospital Authority:

A separate public entity existing independent of local government and governed by a separate board, often with the involvement of local government. A hospital authority may be organized under generic, statewide hospital authority statutes.

Public Benefit Corporation:

A distinctive public corporate entity providing a benefit to state residents. While several states have a body of law applicable to PBCs, this model is generally developed with unique enabling legislation drafted to address the needs of the particular health system.

Appendix A: Methodology

Each year, the National Association of Public Hospitals and Health Systems (NAPH) reports on the financial and utilization characteristics of its membership, which is comprised of approximately 100 safety net institutions across the country. This report is an update on the status of our members based on data collected through the NAPH Hospital Characteristics Survey for fiscal year 2002.

In 2002, 82 NAPH members responded to the annual survey in time to be included in this report. Some members are excluded from certain tables due to missing or incomplete data. Fewer members are represented in the various trend analyses because we relied on a matched set of hospitals that have consistently participated in the survey over the years. This methodology allows us to ensure comparability over time.

In order to compare NAPH members to other acute care hospitals nationally and in the markets they serve, we relied on data from the American Hospital Association (AHA) Annual Survey of Hospitals for 2002. AHA has conducted this survey since 1946 and uses this tool to collect data on organizational structure, facilities, services, community orientation, utilization, finances, and staffing.
